## 1. Introduction

Ahmad Packaging ("we", "us", or "our") respects your privacy and is committed to protecting any personal information you share with us. This Privacy Policy explains what information we collect when you visit our website at [www.ahmadpackaging.com](http://www.ahmadpackaging.com), how we use it, and your rights in relation to it.

This is a product showcase website, not an e-commerce platform. We do not process payments or store any financial information. The primary way personal data is collected is through our Request for Quote inquiry form.

## 2. Information We Collect

### 2.1 Information You Provide

When you submit a Request for Quote, we collect only the information you voluntarily provide, which may include:

- Your name
- Company or business name
- Email address
- Phone number
- Your location or city
- A description of your packaging requirements
- Any additional message or notes you include

### 2.2 Information Collected Automatically via Wix

This website is hosted on the Wix platform. Wix automatically collects certain technical data when you visit any Wix-hosted website. This may include:

- Your IP address and approximate geographic location
- Browser type and version
- Device type and operating system
- Pages visited, time spent, and navigation behaviour

- Legitimate Interests: We process inquiry records to manage our business operations and respond to potential customers
- Legal Obligation: We may retain certain records where required by law

## 6. Data Storage and Security

### 6.1 Where Your Data is Stored

Inquiry submissions are received via our Wix-hosted form and delivered to our internal email. Data may be stored within Wix's infrastructure as well as on our own internal systems. Wix stores data on secure servers and complies with applicable data protection standards.
